8:15 am (55 min)	 Action Item – Approve July 2018 Minutes <u>Subcommittee Reports</u> Mental Health Subcommittee Research Alliance Action Item - Human Trafficking Legislation Language Approval 	A motion to approve the July 2018 meeting minutes was made by Paul Wilde and seconded by Eric Fredericksen. The motion carried. Eric Fredericksen gives presentation on the human trafficking legislation language. Discussion on specific pieces of language: "but is not limited to" after "include" to be added to 18-8602. In section 18-310(2) discussion regarding the language of requiring certain services in safe harbors. "Should" rather than "may" should be used. Even stronger, "must" should be used to avoid ambiguity. Some services will be required in-house, while others must be there, but not necessarily required in-house. Language changes: " be placed in stable housing in a certified residential care facility pursuant to section 39 chapter 12 that provides: 1. comprehensive case management; And provides access to 2. Integrated mental health and chemical dependency services, including specialized trauma recovery services; 3. Education and employment training services; and 4. off-site specialized services." to be added. A motion to move forward with the human trafficking legislation language was made by Paul Wilde and seconded by Melissa Wintrow. The motion carried .

9:10 am (60 min)	"Annual Report on Re-Entry Strategies, Strengths and Challenges" – Jason Stone, IDJC, Henry Atencio, IDOC & Sandy Jones, ICPP	Jason Stone gives presentation on reintegration. Discussion on My Sober Life. A question was raised on current data on the use by users. Stone explains that there is not currently, but in 6 months to a year there will be data on the usage.	
		 Henry Atencio gives an update from IDOC. Reentry manager position created and given a lot of power to break barriers. AmeriCorps Grant information given: \$ 3 million over 3 years, allows for hiring of six case managers, One-stop shop, 1600 volunteers go into prisons and help. A question was raised about the progress on felon employment. Atencio explains that it is not difficult to find felon's jobs when economy is good, tougher when 	

10:10 am (20 min)	Break	 economy is more competitive, but jobs are there. Trying to create more apprenticeships. Goal is the complete academic portion in prison, and then get them to a reintegration center to get their hours. A question was raised about the female population having the same options as male population in terms of higher paying jobs. Atencio explains that this is a concerted effort (yes), but it is a work in progress to achieve gender parity. A question was raised about the one stop shop specifically about those who are released in other parts of the state (outside of the Treasure Valley). Atencio explains that it is starting in the Treasure Valley where they want to show success first, and see positive outcomes before expanding to other parts of the State. Sandy Jones adds that the ICPP is interested in the process of making sure the commission isn't missing anything. Discussion on validation of a parole guideline document. 	
(20 min) 10:30 am (15 min)	Statewide Contract for Drug Testing –Scott Ronan, Program Manager, Administrative Office of the Courts	Scott Ronan gives presentation on drug testing: The administrative office of the Supreme Court is testing the feasibility of a statewide drug-testing program. Drug testing could save lives as well as hold offenders accountable, especially as it relates the growing opioid addiction crisis. Costs of drug testing can be significant. Costs vary by jurisdiction. A statewide drug-testing contract for drug testing supplies already exists. Some jurisdiction may be better and negotiating contacts. A statewide program may reduce costs via buying in volume and other reasons. Henry Atencio explained that UA's are very time consuming for employees and asked: could we get contract labs to perform the UA's rather than state employees such as probation officers? Scott Ronan replied that the Courts have the same goal. The Commission put its support toward a move for further research to support a statewide drug testing contract. Next report on research conducted by Scott Ronan to be given at a later date.
