- b. If we need to take this to agencies, we can, but the obstacle is getting people to come to us. Maybe we could go to something that is already on the calendar and get in if they have room for us.
- c. Let's get this down on a timeline because there are a bunch of meetings already calendared starting at the first of the year. Tanea Parmenter will build a calendar so we all can see what is coming up.
